#### 1. Background

One of the main duties of Ministry of Urban Development and Land (MUDL) in the framework of the Government of Islamic Republic of Afghanistan (GoIRA) is to facilitate citizens' access to basic urban services through formulation of urban plans and policies. The population of Capital Kabul has dramatically increased since 2002. This increase is attributed to the fact that majority of the returning families from neighboring countries got settled in Kabul City. On the other hand, due to security, economic and social conditions, many families shifted to Kabul from other provinces of the country and the process still continues. This has brought not only residential establishments in Kabul under immense pressure but also created serious need for expansion of commercial establishments and urban services.

To facilitate citizens' access to basic urban services, get optimal use of the country resources and reduce housing problem in the country, Ministry of Urban Development and Land intends to formulate plans and concepts for better and efficient use of the vacant government lands in Kabul and other cities. Optimal use of government land by developing them in accordance with the Master Plan and urban norms contributes not only to economic growth but it also helps in improving appearance of city in short and long runs, creating thousands of jobs and improving urban services.

Ministry of Urban Development and Land's policy is to pioneer in attracting private investment in public projects by providing necessary and legitimate facilities for the growth and development of private sector. Taking into account the significance of Public Private Partnership, Ministry of Urban Development and Land developed a preliminary concept for building an international currency and stock exchange market in the vacant land of the Ministry of Communication and Information Technology (MoCIT) adjacent to Sara –i- Shahzada Market in the heart of Kabul city. The MoCIT vacant land is located in a very valuable place in the center of Kabul City. Currently, only a two-story old building is located there where a government office is temporarily based.

According to clause 15 of the resolution # 19 of the cabinet of Islamic Republic of Afghanistan dated 17/09/1395, ownership of (13,269) square meter vacant land adjacent to Sara –i- Shahzada has been transferred to the General Directorate of Amlak and Ministry of Urban Development and Land has been tasked to develop PPP concept for the mentioned land and present it to high economic council for approval. The basic concept has been prepared by the Ministry of Urban Development and Land in close collaboration with the General Directorate of PPP of the Ministry of Finance and was presented to High

Economic Council 14ht meeting dated 10th April 2016, where the concepts were approved in principle and further economic and financial analysis were instructed to be conducted.

#### 2. Objectives of the Assignment and Scope of the services

The general purpose of this assignment is to procure the consultancy services of a competent national or international Architectural and Engineering Firm for the detailed concept development, design services, cost estimation, preparation of tender documents, and operation and maintenance manual for Afghan currency and stock exchange market.

MUDL's Objective is to build land mark commercial building which will:

- Provide productive stimulant working environment for the market, operating personnel, business associates, clients and visitors
- Attract and retain excellent tenants intending to lease or buy in such market as well as clients
- Enhance the economic vitality of the area
- Introduce green building and environmental friendly commercial market

MUDL intends to award the Design Consultancy Services to a qualified local or international Consulting firm who will provide the concept design and programming, architectural and engineering drawings and designs, cost estimations, as well as implementing practices, the necessary Construction Documents in order to tender the Project through PPP Build, Operate and Transfer (BOT) approach and operation and maintenance manual of the Building.

The scope of services covers the entire project's life cycle from Concept Design, Architectural and Engineering design, Cost estimation, and Program Management to Procurement based Support Services. #### 3. Qualification Requirements/Short listing Criteria:

National Procurement Authority on behalf of Ministry of Urban Development and land (MUDL), GoIRA, now invites eligible consulting firms ("Consultants") to indicate their interest in providing the services described under paragraph 3 above. Interested Consultants should provide information demonstrating that they have the required qualifications and relevant experience to perform the Services.

#### The short listing criteria are:

- a) The Consultant should be registered legal entity and should have been in business for at least the last 5 years in providing Consultancy Services of similar assignments. (The consultant is required to provide the Copy of the Certificate of Incorporation issued by relevant authority in country of establishment).
- b) The consultant shall demonstrate having sound financial situation by submitting audited financial reports or any other credible financial documents in which the consultant annual turnover for any of the last Five (5) years (2015, 2016, 2017, 2018 and 2019) shall be at latest USD 1, 400,000 (One Million and Four Hundred Thousand US Dollars).
- c) The consultant should provide proven experience of having executed at least one contract during the last Ten (10) years of similar nature indicating the complexity, duration, value, years of performance, which should showcase the expertise/strength of the consultant for the undertaking such assignments. The Consultant while describing the assignment(s) for similar experience should furnish the following details:
  - Consultant should explain in what way the executed assignment(s) was/were similar in nature to the current assignment.
  - The Consultant should explain the exact role played by the Consultant in the assignment if the assignment was carried out in association with other firms as JV or in sub-consultancy for carrying out the assignment.
  - d) Consultant having some regional experience is desirable.
  - e) The requirements for Consultants who intends to associate with other firm(s) in the form of a Joint Venture (JV) or sub-consultancy to enhance their qualifications are indicated as under:

- I. The <u>lead partner is required to be identified clearly</u> and state the composition and nature of their association (JV/ sub-consultant) in their EOI. In case of JV, the following minimum requirements shall be fulfilled:
  - i) Lead Partner: Shall meet at least 60% of the shortlisting criteria for annual turnover and experiences requirement defined under Part 4 above (Qualification Requirements/Short listing Criteria), paragraphs (b) and (c) respectively.
  - ii) JV Partner: Shall meet at least 25% of the shortlisting criteria for annual turnover and experiences requirement defined above (Qualification Requirements/Short listing Criteria), paragraphs (b) and (c) respectively.

When fulfilling the above minimum requirements, in aggregate, either the lead member and/ or JV partner(s) shall meet at least 100% of the short listing criteria referred to above.

- II. The short listing criteria provided under Part 4 above (**Qualification Requirements/Short listing Criteria**), paragraphs (b) and (c) will not be applied for sub-consultant.
- f) The Consultant should furnish only true and factual information in the EOI (for itself, its partners and sub-consultant(s), if any). By an act of submission of an EOI against this REoI, the Consultant shall be deemed to be aware that for any misrepresentation by the Consultant in regards to its EOI including any qualification documents/ information about the consultant itself, its partner and/ or sub-consultant detected at any stage of selection process or during execution of the resultant contract, if successful, the Consultant will be prosecuted under the Laws of Afghanistan.
